Don welcomed Sonia to the role of Chairperson and gave special thanks to Mark for his work and commitment to the Executive and to NASCA over the past 4 and half years.

# 5. Chairperson's Report

Mark gave a summary of NASCA events over the past year noting the following:

- Thanks to the Executive and Finance Team for their collaboration and hard work over the past year
- Membership similar numbers to last year with 28 Principal members, 21
   Associate, and 6 pending payment
- Meetings the pattern of 4 general meetings per year continues with good attendance of 30 40 attendees at each meeting. The September meeting was the 2 day National Forum.
- Working Groups over the past year In Between Travel, MoH Disability Workforce Planning and Health & Safety
- The major work undertaken this year included:
  - establishment of the National Practice Advisor Role and progress with the associated work programme
  - significant input into the NASC DIAS Review including commissioning the Dr Simon Duffy position paper on system transformation building on current NASC expertise and value.

### 6. Treasurer's Financial Report 2015-16

Don provided a summary of the Audited Financial Statements for NASCA for 2015-16 which had been circulated to Members and is available on the NASCA website.

- NASCA remains in a good financial position with most revenue being generated from MoH contracts such as NASC National Reviewer, National Practice Advisor, Socrates, and Specified Services for the administration of NASC and DSS Meetings.
- A summary of the financial report was given noting a surplus of \$39K for the year, and overall accumulated funds of \$189K compared to \$150K for the previous year.
- The Audit has been completed and signed off by BDO Waikato.
- The full report is available on the NASCA website.

Craig Hutchison raised queries regarding:

- Entity Information noted that the wording does not align with the Mission and Constitution.
  - Mark advised that there had been changes in the accounting format required this year, which had been a challenge for all, and that next year it will be correct.
- Noted that the surplus this year had decreased. Income and expenditure have increased / decreased disproportionately. Did this imply that contract income was not fully covering expenses? Also noted nearly \$190 in accumulated funds - is there a future plan for using this resource?
  - Don advised that overall Ministry contracts were certainly covering expenses, and that the reduced surplus reflected NASCA undertaking particular projects such as the Simon Duffy position paper and other work relating to the NASC DIAS Review. Mark endorsed these comments and noted that the Executive would continue to consider options for use of financial reserves that would be most beneficial to NASCA members.
