Proxy Voting:

Craig Hutchinson made reference to the NASCA Constitution noting the view that it is the organisation that is the member, rather than an individual, which would mean that any persons present from an organisation which is a paid up member should be entitled to cast a vote in accord with the number of Principal memberships held by that organisation.

5. Chairperson's Report

Mark Brown reported and commented on NASCA events over the past year.

- Thanked the Executive for their work and collective efforts to continue and extend the work of NASCA both as a peer support and network for members as well as engaging and influencing policy and practice directions of funders.
- Thanked the Finance Team and the Executive Assistant for the extra work entailed in the Funded Family Care (FFC) monitoring and reporting.
- Membership has been maintained with similar numbers to last year there are currently 27 Principal members, 14 Associate members, and 8 pending payment. A number of new mental health NASC members have joined this year.
- Meetings the pattern of 4 general meetings per year continues with good attendance of 30 40 attendees at each meeting.
- Workshops Mitchell Pham (Christchurch) and Michael Kendrick (Wellington) good attendance and contribution to future thinking regarding Information Systems and Values based NASC practice respectively.
- NASCA 2015 Forum Mark paid tribute to Susan Bowden and the committee for planning and co-ordinating a successful Forum with approximately 90 attendees.
- The Executive have continued with good success to build strong relationships with DSS MoH both through Reference Group meetings and week by week interactions. Efforts have continued towards working collaboratively with HOP and Mental Health funder groups.
- Working Groups NASCA representation has continued with involvement in In Between Travel, EMS Challenging Behaviour, MoH Disability Workforce Planning, Health & Safety, and DSS Service Specifications.
- Projects During the year NASCA:
 - o produced Guidelines for development of Vulnerable Children Policy
 - o undertook work on DSS Review and Reassessment project
 - developed with MoH DSS a work programme for 2015-16 encompassing 10 project streams. We are hopeful that DSS will sign off on resource for a National Practice Advisor Role to manage and progress the work programme.

6. Treasurer's Financial Report 2014-15

Don Sorrenson provided a summary of the Financial Statements:

- NASCA remains in a good financial position with most revenue being generated from DSS MoH contracts such as: Specified Services (DSS Meetings), NASC National Reviewer (Jan White), Socrates (Julia Arnold), and the Family Funded Care (FFC) Monitoring Contract.
- The audited Financial Statements for the year ended 30 June 2015 were referred to and are available on the NASCA website.
