5. Chairperson's Report

Mark presented the Chairperson's report noting that:



• NASCA had a good year in 2013/14, even though there had been some difficult and challenging times. For DSS challenges had been around uncertainty regarding the impact of Enabling Good Lives and future approaches to NASC roles and functions.

For Health of Older People challenges had been around not being invited and included in key development and decision-making work.

- The NASCA Forum in September last year had been very successful and plans were getting underway for a similar forum for 2015.
- Regular networking and speakers at quarterly General Meetings have been well received with attendances of 30 40 at each meeting, including a good number of new representatives attending.
- NASCA is in a strong position financially.
- We have maintained and enhanced a strong partnership with DSS MoH.
- We have had some success with building connections with key people in Ministry and DHBs regarding Health of Older People NASC.
- The Mental Health stream have brought on board several new members and have begun regular monthly teleconferences.
- During the year we have progressed DSS projects on: E-filing, Business Continuity Planning, Review and Reassessment, and begun a discussion document on future DSS NASC options.
- NASCA has maintain representation on many workstreams including: HOP payment systems, EMS Prioritisation, EMS Challenging Behaviour, Spinal Cord Impairment, Workforce, Careerforce Qualification Review, Auckland University Graduate Diploma, DSS Framework Redesign, and DSS Service Spec Review.
- Encouraging progress on work on eligibility and grey areas between streams.
- Today there are 23 Principal Members, 15 Associate Members and 7 memberships pending.

6. Financial Report

Don Sorrenson presented the Financial Report:

- Final statutory accounts audited for 2013-14 were tabled, and will be available on the NASCA website
- Current financial position is good showing a net surplus of \$40K for the year.
