NASCA Executive - Nominations

We are not therefore calling for nominations for the Chairperson role at this time.

There is currently one vacancy on the Executive due to Helene Dore's new role as National Practice Advisor. The Executive have decided to seek nominations to fill this

vacancy rather than making a secondment. The March 2016 meeting will include a brief Special General Meeting for election for this vacancy on the Executive.

Nominations are therefore sought for a member of NASCA Executive. Nominations must be made on the <u>NASCA Nomination</u> Form. The Nominee, the Nominator and the Seconder must all be representatives from paid up Full Members of NSACA.

Nominations will close on **Wednesday 03 February 2016** with the <u>NASCA EA Judy</u> **Preston**.

MoH Review of DIAS & NASC

This survey relates to the NASC and DIAS review being undertaken by Ministry of Health DSS. The MoH have contracted the consultancy company Sapere to undertake the review which is a two part process with a focus on:

- The function of disability information, including the current arrangement through Disability Information Advisory Services (DIAS), to propose a disability information framework which ensures effectiveness of delivery, reduced duplication, value for money and best outcomes for disabled people, family, whanau.
- 2. The functions of assessment, coordination and budget management



within the Ministry's contracted Needs Assessment Service Coordination (NASC) organisations and propose a framework for effective delivery of these functions with reduced duplication, value for money and best outcomes for disabled people, family, whanau.

NASCA is seeking views and comment from NASC Managers and practitioners which will help inform input NASCA has to the NASC - DIAS Review. The Review Sapere is undertaking is limited to review of DSS NASC but comment in this survey is welcome from any member of NASCA.

The <u>survey</u> will be open through to **Monday 25 January 2016**, and the Executive would appreciate your feedback and thoughts.

In addition to this feedback from NASCA Members the Executive are also seeking input from Simon Duffy an expert on disability system design from the UK with a view to writing a position paper for input into the Review.

We understand that the process Sapere intend to take is a period during February and early March of information gathering. They then envisage putting up for discussion a number of options, and seeking further comment and input from NASCA at that stage.

Explore Behaviour Support Service Review of Key Documents

Explore are in the process of reviewing their key documents, and have sought NASCA assistance as a key external stakeholder. Raewyn Cameron, Renee Delamare and Karen Bailey will represent NASCA in this review.

'Taking Action on Fetal Alcohol Spectrum Disorder (FASD): A Discussion Document

As signalled at the Christchurch General Meeting the MoH have released a discussion document and are seeking submissions on Fetal Alcohol Spectrum Disorder (FASD).

FASD is caused by the consumption of alcohol during pregnancy. About half of all pregnancies are exposed to alcohol, and about 1% of the New Zealand population is estimated to have FASD as a result. FASD can be characterised by a range of problems such as intellectual and behavioural deficits, as well as irreversible damage to the brain and body.

This discussion document outlines the Government's proposed approach for addressing FASD. It outlines a series of key principles, high level outcomes and potential action areas for the action plan and seeks feedback and submissions either by email or post – details are in the link.
