## DSS Update

Mark and Sonia had a meeting yesterday with Toni Atkinson and Phil Wysocki and had some productive discussion regarding some of the pressures and issues for NASCs including budget management and ICARE etc. We value the positive working relationship we have with the Ministry which allows us to openly discuss matters of concern. We do not always have to agree but all points of view are heard. A couple of quick items to feedback:

- We discussed the burden of some recent ad hoc requests by the Ministry for example – going back to potential users of Funded Family Care to gain some understanding of reasons for not taking up this option. Toni Atkinson was very appreciative of the work those NASCs who responded had been able to do on this. The feedback has given the Ministry valuable new insight into why people had not chosen the FFC option.
- The Ministry reiterated that all DSS NASCs should be promoting FFC as an option, if the person is eligible, at the time of assessment or reassessment.
- NASCA will be providing the Ministry with a proposal to jointly work on:
  - Additional support for the project management and implementation of ICARE probably in conjunction with the project work that NASCA is already planning.
  - Provision of regular comparative data on service line and package allocations across all DSS NASCs

(information definitions to be developed) ie similar information as presented by Toni at the National Operations Meeting but across wider range of service lines.

- The project work already being considered and scoped by NASCA.

We will be able to give more details on these initiatives in the next couple of weeks.

## Worker Safety Check Regulations & Guidelines

New government regulations made under the Vulnerable Children Act 2014 require state-funded organisations who work with children to have all their paid children's workforce safety checked. Phases apply:

**1 July 2015** - all core children's workers as new employees or contractors are safety checked before they start work.

**01 July 2016** - all non-core children's workers as new employees or contractors.

**01 July 2018** - all existing core children's workers.

**01 July 2019** - all existing non-core children's workers.

**Core children's workers** are paid or funded by state sector agencies and work alone with, or have primary responsibility or authority over, children (examples of roles that may meet this definition include: doctors, teachers, nurses, paediatricians, youth counsellors and social workers)

**Non-core children's workers** are paid or funded by state sector agencies and have regular, but limited, child contact (examples of roles that may meet this definition include: non-teaching school staff, general hospital staff and many social and health workers).

We believe that NASC roles will generally fall under the non-core category.
