Vulnerable Children Act and implications for NASCs

Child Protection Policy Guide: Following the presentation to NASCA in Christchurch in December NASCA commissioned Child Matters to develop a 'Child Protection Policy Guide'. This is designed to support all NASC services with a framework from which to:

- evaluate and assess child protection policies currently existing within your organisation, or to
- write and develop a child protection policy for your NASC or your organisation

The policy guide includes recognition of the requirements for child protection policies under the Vulnerable Children Act, 2014, and also guidelines for best practice for comprehensive child protection policies and practices.

Disabled Children Voluntary out of Home Placement Review

The current review is a joint project of MSD and MoH. The purpose of the review is to understand what could be done differently to support, protect and empower disabled children who are (or face the possibility of being) placed in out-of-home care, under sections 141 and 142 of the Children, Young Persons, and Their Families Act, 1989. The areas of interest are on what needs to change to ensure disabled children have the same rights as other children to live in a family environment, and if they are unable to live with their own family, to find out what changes are needed to provide an effective system.

Consultation closes on 29 May. Further information is available on the MSD Website including the Submission Form, and the Public Consultation Document.

Reducing Harm from Falls Programme

Reducing harm from falls is the fifth focus for the <u>Open for Better Care</u> patient safety campaign supporting the Health Quality & Safety Commission's <u>Reducing Harm from Falls</u> programme.

The theme is 'Stand up to Falls' and focuses on an integrated approach across the health sector to falls in older people. This theme applies in all care settings – it is as pertinent at a central agency level, as it is across hospital, aged residential care and



primary/community care settings. Having older people at the heart of everything we do is essential.

The 'Stand up to Falls' campaign commenced in April with a month-long profile through April Falls activities including the release of the Atlas of Healthcare Variation falls domain and other resources for download.

Productivity Commission Report Released

The New Zealand Productivity Commission has recently released their draft report 'More Effective Social Services'. This is now open for public discussion and response by 24 June 2015.

The recommendations are far reaching in their potential effect on the health and disability sector. There are a large number of findings and recommendations and the 'devil will be in the detail' as to how government picks up implementation. A couple of examples:

R11.1 When commissioning services, the Government should look to empower clients where such empowerment would not be detrimental to the client or the broader interests of society. Disability support services, home-

based support of older people, respite services, family services, and drug and rehabilitation services are good prospects.

R12.3 Departments, agencies and non-government providers should expand the use of contracting for outcomes where it is efficient to do so.

R12.4 The Government should improve the capabilities of agencies to contract for outcomes, ideally with payments for outcomes achieved in those contracts.
