Navigator Model

The MOH DSS through NASCA are calling for expressions of interest from a NASC interested in implementing the Navigator Model in their region. MOH DSS have agreed to one-off funding to support NorthAble NASC to provide expertise, training material and guidelines to implement Navigation into another NASC region.

NASCA is seeking expressions of interest from any DSS NASC interested in taking up this opportunity to implement the Navigator Model in their region. Please forward your expression of interest with a brief statement regarding your interest and how you would envisage utilising the Navigator Model in your region, to NASCA EA Judy Preston by 12 noon Thursday 24 April 2014.



Selection will be undertaken in consultation with the MOH.

The MOH are keen to see this take place over the next few months and be substantially complete by 30 June 2014, with an implementation progress report due by early July 2014.

Note that the MOH require the NASC to operate the Navigator model within their existing discretionary funding (DF).

<u>HOP - Access to interRAI for interNASC transfers</u>

Following the discussion at the Wellington General Meeting, a trial has been set up between the 3 lower North Island NASCs (C&C, Wai and HV), providing key staff access to the other DHB's Momentum offices. This has allowed all assessment information to be viewed by the receiving NASC, without any documents needing to be transferred by fax or e-mail. This has proved to be very beneficial in terms of saving in documents and paper, and the ability to use system to its full extent considering the needs of any potential transfers has significantly reduced the time required around consideration of transfers.

In principle, there is nothing to stop this being rolled out more widely. Information for discussion will be sent to NASCs ahead of the June meeting, where we can discuss any plan for wider implementation.

HOP - N1004 Referral form

Many of you will be aware that there has been some work being done by MOH Sector Services on revising the N1004 form, but very little communication or consultation with DHB NASC's. (What has happened appears to have been done primarily with portfolio managers). Several **NASCA** members have been advocating the key staff in the Ministry of Health, and we can advise that a further workshop will be held in May, and a commitment has been made to involve NASCA. In the meantime there is no date for implementation of any changes.

Carol presented the Template and Guide at the recent General Meeting and since then has been working with FOCUS on their BCP and has created a different version of Table 6. Other NASCs might like to consider this as it is easier to see the likely impacts across critical functions. MSD - Health and Disability Long Term Work Programme

Ministry of Social Development have a survey running currently seeking feedback on their Health and Disability Long Term Work Programme.

This is a great opportunity to provide feedback to MSD. There is a groundswell of thinking in the wider sector that lack of employment for disabled people is very often about discrimination and a disabling labour market. Almost all of the MSD stated policy objectives are focused on forcing disabled people to adapt to this discriminating market rather than on encouraging employers and society to change.
